#### PUBLIC PARTICIPATION DURING BOARD OF TRUSTEES STUDY SESSION

#### Instructions for Submitting Requests for Public Comments Related to Study Session Topics

Members of the public may address the Board of Trustees by oral presentation related to Study Session Topics provided the requirements and procedures herein set forth are observed. All public comments will be subject to the general rules set forth below.

- Generally, three minutes is allotted to each speaker for related to Study Session topics. The speaker must adhere to the topic.
- Individuals wishing to speak to a related to Study Session topic will be called upon at the time that the Board reaches that item in the agenda.

Exceptions: This time allotment does not apply to individuals who address the Board at the invitation or request of the Board or the Superintendent

Any person who disrupts, disturbs, or otherwise impedes the orderly conduct of any meeting of the Board of Trustees by uttering loud, threatening, or abusive language or engaging in disorderly conduct shall, at the discretion of the presiding officer or majority of the Board, be requested to be orderly and silent and/or removed from the meeting.

No action may be taken on items of business not appearing on the agenda

## Instructions for Submitting a Request to Speak at In-Person Meeting

Individuals wishing to speak to the Board on a Study Session topic must complete a request card with name, address, name of organization (if applicable) and the topic or item on which comment is to be made.

 The request card to speak must be submitted to the recording secretary at the meeting before the Board reaches that specific item on the Study Session agenda.

#### Instructions for Submitting a Request to Speak at Zoom Webinar

The Zoom webinar format used by the Board of Trustees Zoom meetings ensure public participation and provide an opportunity for the public to directly address the legislative body. Individuals wishing to speak to the Board can do so in one of several ways:

It is recommended that Individuals wishing to speak at the Study Session webinar send an email to Recording Secretary (Rose Lisa@smc.edu) by 4:30 p.m. for the. for the Study Session starting at 5 p.m. The email should contain the subject line "Board Meeting Comments" and include the following information in the body of the email:

- Name
- Address
- Name of organization (if applicable)
- Study Session Topic

Alternatively, during the meeting and before public comments have ended, individuals may use the Q&A feature of the Zoom webinar to request to speak.

When it is time for the speakers to address the board, their name will be called and the microphone on their Zoom account will be activated. A speaker's Zoom Profile should match the name used to request to speak to expedite this process.

After the comment has been given, the microphone for the speaker's Zoom profile will be muted.
